#### **ROLL CALL:**

#### FOIA:

#### **MAYORS REPORT:**

Advised Scott Montgomery with McLeod advised that the Loris Facility has not reached capacity.

#### **DEPARTMENTAL REPORTS:**

#### Police Department:

Chief Buley advised that Loris was recently involved in a drug operation that resulted in the Federal Inditement of 28 subjects. Advised that Lieutenant Williams and his involvement with the DEU Taskforce was instrumental in the operation.

# A. SECOND READING OF ORDINANCE 07-20 TO ADOPT A BUDGET FOR THE CITY OF LORIS, SOUTH CAROLINA FOR THE FISCAL YEAR 2020-2021 ENDING JUNE 30, 2021

Amanda F. Causey read the ordinance by title only.

Councilman Suggs advised that the addition was incorrect in the last full paragraph on page one. The millage total listed on page was incorrect and needed to be corrected to reflect 110.8 mills.

Councilman Padgett made a motion to approve the budget for second reading of Ordinance 07-20 TO ADOPT A BUDGET FOR THE CITY OF LORIS, SOUTH CAROLINA FISCAL YEAR 2020-2021, with the amendment to the millage to reflect 110.8 mills, seconded by Councilman Lewis Hardee.

All members voted favorably.

## B. FIRST READING OF AN ORDINANCE 09-20 TO SEPARATE CLERK TREASURER INTO CLERK AND TREASURE

Amanda Causey read the ordinance by title only.

Councilman Padgett read into record the following corrections:

- a. Update Section 2-183 to reflect City Clerk and/or City Treasurer
- b. Add signature of licenses to Clerk duties
- c. Section 2-196 change City Manager to City Administrator
- d. Second paragraph, second sentence correct City Treasure to City Treasurer
- e. Change from all fees to all fees and license

Councilman Suggs stated in Section 2-183 the title should state Bond not Salary. Councilman Suggs requested to expand the notification audience in Section 2-195 to include department heads.

Councilman Padgett made a motion to adopt the First Reading of Ordinance 09-20, with requested corrections, seconded by Councilman Lewis Hardee.

All members voted favorably.
