#### **CALL TO ORDER:**

Chairperson Linda Morrison called the meeting to order at 4:00 pm on Thursday, March 23, 2023. The invocation was given by Ms. Jones.

## **APPROVAL OF MINUTES:**

1. Minutes from October 24, 2022

Mr. Brogdon made a Motion to approve the minutes as presented; Seconded by Ms. Jones. All members voted in favor; the Motion passed.

# **NOTICE OF PUBLIC HEARING:**

1. 202302-001: Request to annex 0.23 acres into the corporate limits of the City of Loris as R-2 (Medium-Density Residential) located along Dewitt Street [PIN: 176-11-01-0011]

Ms. Holmes stated that the subject property was adjacent to Watson Park and contiguous to the R-2 zoning district. Mr. Brogdon inquired about what was currently on the property; Ms. Holmes responded that there was a manufactured home on the lot, but the setup was not complete at this time. Local resident, Ms. Carletta Melvin (5110 Dewitt Street), stated her approval of the proposed annexation. The applicant, Mr. Michael Bellamy, stated that he had started with Horry County regarding the permit process and was informed that he would need to create a cul-de-

sac and increase the driveway before his manufactured home setup would be allowed, which he stated that the access to his property was existing at the time of his application and other various hardships Horry County had placed on him with regard to his property. Ms. Jones questioned whether Dewitt Street was a state or county road; Mr. Dobrydney stated that it was a statemaintained road.

Ms. Jones made a Motion to recommend approval of this Request for Annexation to City Council as presented; Seconded by Mr. Birdsell. All members voted in favor; the Motion passed.

# 1. Review Planning Commission By-Laws & Procedures

Mr. Dobrydney stated concerns including setbacks and grading for some lots but would provide a complete list for the applicant. Mr. Brogdon made a Motion to defer this matter pending revisions; Seconded by Ms. Jones. All members voted in favor; the Motion passed.

#### 3. Discuss training requirements for members

Ms. Holmes stated that one day would be set aside for all new members who need the initial training and members needing the annual training would be done prior to the start of the next meeting. Administrator Young stated that he would like members of the Board of Zoning Appeals to be present during future Planning Commission meetings.

## 4. Updates from Staff

Administrator Young reiterated his appreciation for having Mr. Dobrydney assist with the complexities of dealing with zoning and land development.
